# **Salem Civic Association Meeting 9/24/19**

Approval of last month's minutes.

### Officer Clinger

- Report from Woodward park area. Pictures had been sent of a guy that was breaking into cars and he got another picture today and it is the same guy. He was living in the Giant Eagle Parking lot, but is no longer there. Think maybe he is the guy pitching a tent in the Woodward park. It is against the law to camp in a park. Keep your eyes out. He is a white male about 6'2 gray hair on a bicycle. Aged from addiction. Looks about in his 50's. Call the CPD if you have a concern. Officer Clinger will check daily.
- Railroad have their own jurisdiction. CPD cannot do anything about the railroad. There is an 800 number you can call, but officer Clinger didn't have the information with him. The railroad is very aware of the homeless camps that are along the railroad.
- Norma (another civic association) is looking on getting ahold of environmental people due the hazardous waste from the homeless at the railroad tracks by the lake.
- Sheriff's department cannot do anything either due to jurisdiction.
- No updates on the motels. America's Best Value In said they were ready for inspection a few weeks ago. They failed the inspection, so were unable to reopen at this time.
- No concerns at this time with the closure of Sinclair. Freeway Dr is a Columbus street and can call 311 for concerns of street markings.

# Pat - Treasurers report

- Cash available is \$1010.91 as of 9/6/19.
- Line 20 row 20 Column B budget was \$900 and at the last meeting we authorized up to \$400 for the block party which increased the line to \$1300.
- Line 27 Column B budget was \$300; however, donations were \$365 so the budget has now increased to \$365.
- Donations are a source of funding; therefore, donations will go towards the budgeted amount and the excess amount will increase the available.
- Concern over the original budgeted amount vs the budgeted amount + donations. Pat explained that the amount was never reflected in the budget, which is why the bank account has been going negative.
- The board will review at the board meeting on the method of donation.
- Arguments were presented to have donations to make up for the donation amount vs donations go above the allotted budgeted amount out of membership fees/etc.
- The membership approved the new format in June, the budget itself was approved in January. The constitution does not lay out specific accounting procedures. This leaves the board to make the decision. (Pat had a better explanation.

- It was suggested to remove the donation suggestions.
- One of the reasons the format was changes is to show we are spending money that we are not taking in. Line 33 column B.
- It was suggested that we do something to bring in more income and explained that the budget is approved by the membership not the board.
- It was suggested to make a notation on the membership form to indicate that the donations will first go toward the budgeted amount for that line item.
- Treasures report was approved and the board will review the way the budget is managed.
