NCC Report May 2023

- CPD has instituted a Street Racing Enforcement Initiative to target areas where cars are engaging in dangerous high speed street races.
- The City Attorney’s objection to the Doll House on Karl Rd. liquor license renewal is up for a hearing in June, and the Nuisance Abatement enforcement action is up for a hearing in July. It remains closed until outcomes from the hearings are issued.
- America’s Best Value Inn (ABVI) on Sinclair Rd. remains closed due to lack of compliance with the Nuisance Abatement agreement. The City Attorney has scheduled a Receivership Status Conference for the end of June. If no satisfactory outcome occurs at this meeting, the City Attorney will file to have a Receiver appointed by the court to sell the property.
- The Karl Rd. library Summer Reading Challenge kick-off event will be Saturday 6/3 from Noon-2pm.
- The NCC July 4th Parade committee is seeking volunteers to help with planning, promotion and participation. The committee meets on the 3rd Saturday of the month from 1-2pm at Epworth United Methodist Church, 5100 Karl Rd.
